Why?	Financial companies choose how they share your personal information. All financial companies need to share customer's personal information to run their everyday business. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information.
What?	The types of personal information we collect and share can include: <ul style="list-style-type: none"> • Name and Address • Social Security Number • Account Balances, Date of Birth, and Payment History • Credit History and Transaction History When you are no longer our customer, we continue to share your information as described in this notice.
How?	Below are the reasons financial companies may share their customer's personal information; the reasons PACEfunding chooses to share; and whether you can limit this sharing.

WHAT WE DO

How does PACEfunding protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include:

- Secure computers and servers
- Data encryption
- Limiting access to only authorized and qualified personnel
- Secure physical files and buildings.
- Verification procedures to confirm customer identity before processing a credit application or releasing information.

How does PACEfunding collect my personal information?

We collect your personal information, when you apply for a loan. We also collect your personal information from credit bureaus and other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only:

- Sharing for affiliate's everyday business purposes – information about your creditworthiness
- Affiliates from using your information to market to you
- Sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account or application.

DEFINITIONS

Affiliates

Companies related by common ownership or control. They can be financial or non-financial companies.

- PACEfunding has no affiliates

Non-Affiliates

Companies not related by common ownership or control. They can be financial or non-financial companies.

- Admirals Bank
- Non-affiliates we can share with can include non-financial companies such as home improvement contractors

Joint Marketing

A formal agreement between non-affiliated financial companies that together market financial products or services to you.

- PACEfunding does not currently participate in joint marketing with non-affiliates.
